

Undergraduate Year Weightings

- 1.1. The Quality Assurance and Enhancement Committee has agreed, and the Senate has approved, an overall College policy on undergraduate year weightings for Engineering and Natural Sciences with effect from October 2013.
- 1.2. It is expected that a similar policy for the Faculty of Medicine will be considered by the Quality Assurance and Enhancement Committee for approval by the Senate during 2013-14, and which will roll out for students entering the College in 2014-15.
- 1.3. The following weightings for the Faculty of Engineering and the Faculty of Natural Sciences have been agreed on a rolling basis with effect from October 2013.

Notes: All years taken away from Imperial with no tuition will normally have the year abroad year weighted as 0.

All years taken away from Imperial but with modules taken abroad and project marked at Imperial will have that year abroad year de-weighted. Default de-weighting is normally by "1" (as shown in table)

All BSc programmes with final year in the Business School will have that year de-weighted. Default de-weighting normally aligns weighting of the Business School year with the final discipline year (as shown in table)
