

GENERAL TERMS AND CONDITIONS FOR STUDENTS 2021/22

CORONAVIRUS UPDATE

If you are enrolling to study at Imperial for the 2021/22 academic year we understand that you will have questions about how the disruption caused by COVID-19 may change our operations and processes in the new academic year.

Inevitably, we have had to make some changes to ensure that we can continue to keep you and our staff safe. Our priority is for you to experience everything our campuses and London has to offer. We therefore look forward to welcoming our students back to campus for an educational experience that will maximise in-person teaching and research on our campuses throughout the academic year, unless we are prevented from doing so by UK government restrictions or you are registered on a programme that is designed to be fully remote.

We're currently making plans for our academic and student experience in three scenarios:

- under minimal COVID restrictions,
- under partial COVID restrictions, which allows students to be on campus whilst following guidelines, and
- under full COVID restrictions, which means a return to lockdown, should there be another outbreak of coronavirus.

TUITION FEE LIABILITY

You are required to have adequate funds to meet both the tuition fees for the programme of study and to cover any maintenance costs for the duration of your programme of study. Details of fees and funding are published online:

Following enrolment you will be sent an invoice for the fees for this academic session. Non-payment of tuition fees may mean that you are unable to progress with your programme and may be unable to graduate.

If you are sponsored by a third party and the sponsor fails to pay the tuition fees (and/or College accommodation fees where applicable) then you accept responsibility for the full amount outstanding.

VISA REQUIREMENTS

It is your responsibility to ensure that you have permission to study in the UK and that you have a valid visa where necessary. Imperial College may contact the Home Office to check your eligibility to study in the UK.

A student visa requires you to abide by the rules and responsibilities of that visa. Information is published online:
