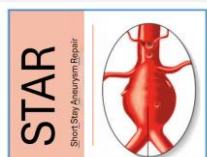

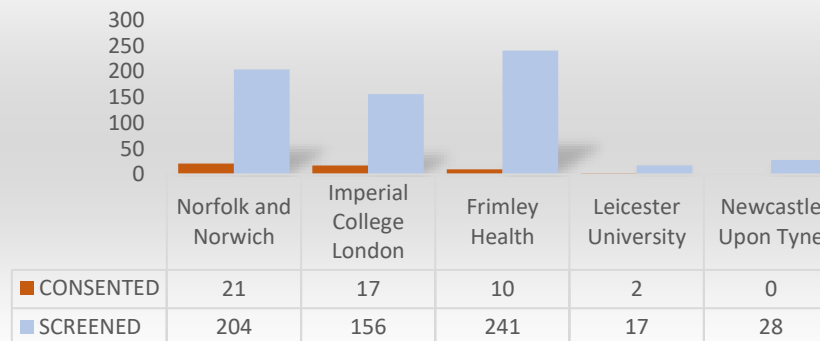

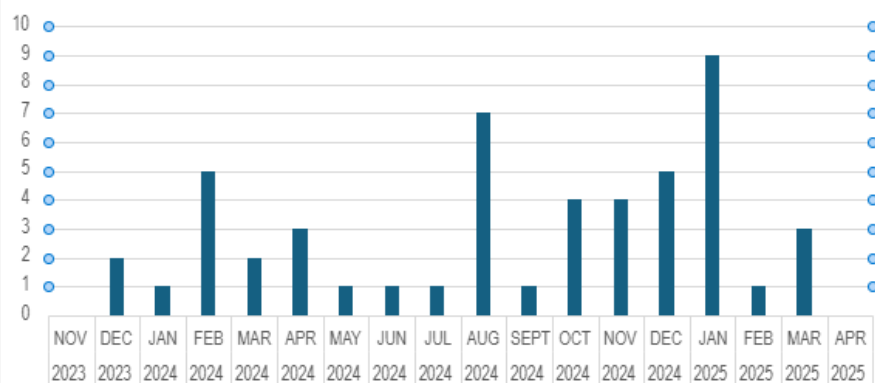

**Friendly reminder to adhere to follow up visit windows outlined in the STAR Protocol v3.0.**

**Any visits outside the study window /any missed visits -should be recorded as Protocol Deviations on REDCap.**

Day 2-4	post discharge	telephone follow up
Day 30	+/- 14 days	routine outpatients' clinic appt
Month 3	+/- 14 days	telephone follow up
Month 6	+/- 14 days	telephone follow up
Month 12	+/- 3 months	from NHS records
